Cooperative Alliance Update

This is an exciting time for Kaw Valley. In this edition of Light Talk you will find information on the replacement of our aging metering system, the hiring of two new employees and the results of our Youth Tour contest.

Perhaps most exciting, or at least the most meaningful to your household budget, is the current alliance and potential consolidation with Leavenworth-Jefferson Electric Cooperative (LJEC). This will play a major role in our future. In our communications, we have consistently pointed to a savings, through this consolidation, of over \$13.5 million over the next ten years. However, we are confident that the savings can be even larger.

We have had unexpected retirements and found additional efficiencies that we continue to capture to push those savings to even higher levels. There are projects to tie our phone systems together, connect our computer networks, enable our radios to communicate with each other and to maximize efficiencies through eliminating duplicate tasks at each cooperative.

With the cooperation of each staff member at both cooperatives, we are capturing the dollars we save in order to demonstrate the benefit of consolidation when the vote is held next year.

You may ask, "With all these savings, will my bills go down?" Unfortunately, the answer is no. However, they won't go up nearly as fast either. Viewing the financial forecasts of each cooperative we have already moved the expected dates of any rate increase down the road. As the savings grow, we will hold rates steady as long as it is financially responsible for us to do so.

Statement of **Non-Discrimination**

Installation of New Metering System

The Kaw Valley Board of Trustees has approved the purchase of a new electronic metering system. These electronic meters will replace both the traditional mechanical, gear-driven meters, as well as several hundred digital meters which already exist on our lines.

Mechanical meters are normally what people associate with

the electric company. Inside, they have gears and a spinning dial that registers your electric consumption. A meter reader comes around each month to get a reading from your meter.

In addition, nearly half our system is equipped with Kaw Valley's new metering system installa-

digital meters, which replaced

older mechanical meters. However. these meters were installed in 1984. Let that sink in for a minute. We are still using technology from a day when Atari was the cool game system and Ronald Reagan was President. Technology has advanced and it is time for an update.

Benefits of this new system

include immediate outage notification to our office, faster outage restoration, tamper detection due to attempted power theft, reduced line losses and the elimination of meter readers. These are all things which either save you money or improve your service.

> Our new system is a power line carrier system, which means


> > over your power line from your

meter back to our substation to show your electric consumption for the month. Meters and substation equipment will be installed over the coming months and we expect the entire project to

> be completed before the end of the year.

During the installation of this new system, it will be necessary for us to gain access to your meter. Employees and contractors will be clearly identified. If you have any questions, please do not hesitate to ask them or to contact our office.


