Your evaluation begins with a Builder Performance Institute (BPI) certified professional visiting your home and completing a comprehensive assessment of the efficiency of your home.

▶ Lighting Analysis—Review of your home's existing lighting and potential savings solutions.

▶ Insulation Inspection—Examination of your attic, walls and rim joist insulation levels and recommendations on how you can improve the overall comfort of your home, including potential savings.

▶ Blower Door Test—This test will quantify airflow, measure heating/cooling air losses and pinpoint specific leaks.



Paying Our Share—2014 LJEC Property Tax Review

LJEC received its 2014 tax bills from the counties in which the cooperative owns and maintains property (line and infrastructure). The cooperative saw a drop in this year's taxes, due to the Kansas Department of Revenue changing

their methodology of appraising electric cooperatives versus other utilities.

Through payment of property taxes, rural electric cooperatives share the cost of the state's educational system, highways and city and county facilities such as roads, libraries, parks and hospitals.

Paying our share of taxes is one way LJEC and nearly 1,000 other rural electric cooperatives help build a stronger America.

LJEC strives to maintain our rates while facing increases such as these.

Material prices throughout all aspects of the cooperative business continue to rise.
