# **Kaw Valley Trustee Election Process Begins**

Kaw Valley Electric Cooperative is governed by a Board of Trustees elected by you, our member-owners. KVEC has a service territory that is divided into nine districts, with each district having one member on the Board of Trustees. Each year, three Trustee positions become open after their three-year term expires.

The following Trustees terms expire as of the KVEC Annual Meeting on April 19, 2016.

- ▶ District 3 **ROBERT L. SAGE**
- ▶ District 6 LARRY BUTEL
- ▶ District 9 ROBERT LYNCH

The process for being nominated to the Board of Trustees is beginning. The Trustees whose terms are expiring can either be nominated for re-election or they can choose to withdraw their name for consideration.

At the same time, other KVEC members who may be interested in serving on the Board of Trustees can be nominated for the election to the Board of Trustees.

Nine cooperative members are appointed

to serve on the nominating committee, and their duty is to select and nominate qualified candidates to be placed on the ballot. This committee will review the names that have been submitted and will then present a slate of nominees to be presented to the membership at the KVEC Annual Meeting for

### What Makes a Good Trustee?

The Kaw Valley Board of Trustees provides a connection between our membership and community at large. You may ask if you have what it takes to serve on our board.

We seek those who have a sincere interest in preserving the strength of KVEC's operations and maintaining a productive relationship with our members. We look for our Trustees to maintain open lines of communication with the districts they serve.

In addition, Trustees work together to ensure equitable treatment to all members across the system, as well as strive to be knowledgeable about trends and circumstances that may affect the members and communities that KVEC serves.

#### Potential trustees must:

- ▶ Be a KVEC member
- ▶ Have a bona fide residence in the district with an opening

#### Potential trustees cannot:

- ▶ Be employed by or financially interested in an enterprise selling electric energy or services
- ▶ Be employed by or financially interested in a business that sells services or supplies to KVEC
- ▶ Be a current KVEC employee or have been an employee within the past three years
- ▶ Be a close relative of a current KVEC trustee or employee
- ► Have entered a plea of guilty or no contest or have been judged as guilty of a felony crime

The time commitment for a KVEC Board Member averages eight hours per month. Some months will be less, and some may need more time depending on issues, decisions, and activities. # **Stay Aware & Stay Prepared for Winter Weather**

As we approach the winter weather season, it is important to remember to be prepared. Winter weather can cause hazardous travel conditions, downed power lines, and extended power outages.

Stay aware. Stay prepared. Know the difference between watches and warnings:

- ▶ A winter storm watch means stormy conditions, including heavy snow, freezing rain, or sleet are likely within the next few days. You should be aware that this means adverse conditions could begin within 12 to 48 hours.
- A winter storm warning means conditions can become adverse within the next 24 hours. Those in the range of the warning should be aware of impending conditions and consider altering plans to travel.
- ► A blizzard warning means an affected area should seek refuge immediately due to high levels of snow, strong winds, and near-zero visibility to those traveling.

Do you have an emergency preparedness kit for winter weather? Your family should be aware of the kit's location and contents.
