Air Leakage and What it Means for Your Electric Bill

Air leakage, sometimes called air infiltration, is one of the largest factors contributing to a higher electric bill. While it is healthy to have some air flow in and out of your home, too much can lead to a home that is too cold in the winter or oppressively hot in the summer. The end result, high electric bills.

Air leakage is caused by the many cracks and gaps that are all around your home. Each penetration in your home's exterior is an opportunity for air leakage.

Checking How Much Infiltration is in Your Home

LJEC offers a blower door test that can calculate how much air leakage you have in your home. This test consists of a door (with a fan at the bottom) that mounts to the frame of an exterior door. The fan will either pressurize or de-pressurize the home, creating air pressure differences. A pressure gauge is used to measure the differences between inside and outside the home and a pressure and airflow gauge.

A blower door is used to measure the airtightness in a building.

A blower door test can be completed in as little as an hour and is available through LJEC for just \$50.

Low Cost Ways to Help with Infiltration

Air sealing and insulation are two of the quickest, easiest and most cost effective ways to combat air leakage.

For our area of the country, the Department of Energy recommends attic insulation have an R-Value of at least R-38 up to R-60. Insulation is relatively inexpensive and easy to install. Depending on whether you're installing insulation in new construction or simply adding insulation to increase your R-value, there are many types of insulation to accommodate your specific needs.

Make sure to inspect your home for any infiltration points. Caulk all cracks and gaps around your home including spaces around wires for telephone, electrical, cable, gas lines, water spigots and dryer vents. Fixing these types of leaks will make a huge difference in the amount able to flow freely from your home.

Blower Door Tests

LIEC can offer our members a blower door test at the discounted rate of \$50. Our member services representative will come to your home to check air infiltration and make recommendations on improvements you could make to your home. Mail-In Ballots Approved

The LJEC Board of Trustees recently approved offering mail-in ballots for the upcoming Board election.

Electric cooperatives throughout the country are experiencing a shift in the landscape in which they operate. Today, cooperatives face the challenges of keeping costs low for their members while implementing new technologies for greater efficiency. Cooperatives are also under increasing pressure to practice good governance and demonstrate that fair, unbiased elections are available to their members.

Adding mail-in ballots will only add to the transparency and unbiased elections that LJEC strives for. General Manager, Steve Foss said "We want our members to have the ability to participate in this process. Changing times necessitates that we change how we offer voting. 
Voting
