SINGLE PHASE TIME OF USE SERVICE

APPLICABILITY

This schedule is applicable to single phase service of single character supplied at one point of delivery used for residential or general use. This schedule is optional, and customers must request to be served under this schedule. This schedule is not applicable to temporary, breakdown, standby, supplementary, resale, shared service, netmetering, or pre-paid billing.

CHARACTER OF SERVICE

Single phase, alternating current, approximately 60 Hertz at available voltage.

MONTHLY RATE

Customer Charge:

Residential Service \$40.50 per month effective January 2025 through December 2025

\$41.00 per month effective January 2026 through December 2026 \$42.00 per month effective January 2027 through December 2027

\$43.00 per month effective January 2028

General Service

\$53.00 per month

Off Peak Energy Charge 11.000¢ per kWh effective January 2025 through December 2025

10.750¢ per kWh effective January 2026 through December 2026 10.500¢ per kWh effective January 2027 through December 2027

10.250¢ per kWh effective January 2028

On Peak Energy Charge 30.000¢ per kWh effective January 2025 through December 2025

35.000¢ per kWh effective January 2026 through December 2026 40.000¢ per kWh effective January 2027 through December 2027

45.000¢ per kWh effective January 2028

ON PEAK PERIOD

The on-peak period shall be 3 p.m. to 6 p.m. Central Prevailing Time, Monday through Friday, and shall exclude the holidays of New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. Time is subject to change by Board of Trustees. All other hours will be considered as the off-peak period.

MINIMUM MONTHLY CHARGE

The minimum monthly charge under the above rate shall be the Customer Charge.

POWER COST ADJUSTMENT

The above rate will be increased or decreased in accordance with Schedule PCA-25, as it currently exists or may be amended.

CONDITIONS OF SERVICE

- 1. Individual electric motor sizes are limited to 10 HP and smaller, unless using soft start or written pole motors approved by the Cooperative.
- 2. Service is accepted for a period of not less than one (1) year, unless the customer's load changes, thereby requiring reclassification to another schedule. If customer subsequently elects a different rate, customer will not be eligible for this rate for a minimum of one year.
- 3. Service hereunder is subject to the Cooperative's Rules and Regulations as approved by the Cooperative's Board of Trustees.
