

Rallying Cooperative Spirit

Official Rules and Regulations – Event Drawings

1. Sponsor

This promotion is sponsored by FreeState Electric Cooperative, Inc. (“FreeState”), located at 1100 SW Auburn Rd., Topeka, KS 66615.

2. Promotion Period

The promotion begins on Saturday, September 19, 2026, and ends at 11:59 p.m. (CT) on November 9, 2026 (“Promotion Period”). Entries received after this time will not be eligible.

3. Eligibility

The promotion is open to active residential members of FreeState who:

- Are at least 18 years of age at the time of entry
- Have an active residential account with FreeState

Commercial accounts, temporary accounts, PowerPay accounts, trustees and employees of FreeState (and their immediate family members or household members) are not eligible to participate.

4. How to Enter

Eligible members will automatically receive one (1) entry into the drawing by completing the following during the Promotion Period:

- Depositing the official entry postcard at one of the five sponsored “Rallying Cooperative Spirit” events.

5. Prize

One (1) winner will receive a bill credit valued at \$100, which will be applied to the winner’s primary residential account. The bill credit will only be applied to one active residential meter (account).

- The prize is non-transferable and cannot be exchanged for cash.
- The bill credit will be applied in accordance with FreeState billing practices until the total credit amount is exhausted.
- Any remaining balance after application of the credit is the responsibility of the member.
- If a member account becomes inactive, the bill credit is forfeited.

- The winner will be selected in a random drawing conducted by FreeState on the following dates:

- If the selected winner cannot be contacted or does not respond within 20 days, an alternate winner may be selected.

- Allow FreeState to use their name, likeness, and general location for promotional purposes without additional compensation, unless prohibited by law
