2014 Highlights & 2015 Outlook

As we wrap up our 71st Annual Meeting, we look back on 2014 and look forward to the future and opportunity.

Retirements

We have experienced a fair amount of change at LJEC in terms of retirements. In April 2014, both Joe Heinen and Steve Poe retired with a combined 84 years of experience. In January, Bob Funk retired with 25 years of experience. This trend will continue at LJEC; we currently have another eight employees becoming eligible in the next five years.

Capital Credits

Capital credits in the amount of \$296,000 were distributed during 2014. The cooperative was able to retire allocations from 1975-1978 and retire a portion of 2013. By retiring a portion of the last year's capital credits, it allows current members to see benefits of membership now. LJEC is, once again, in the financial position to distribute capital credits in 2015. We will be retiring allocations from 1979-1981 and also a portion of 2014 in the amount of \$340,000.

Cooperative Alliance

One major initiative LJEC undertook during 2014 was forming an alliance with Kaw Valley Electric Cooperative in Topeka. On October 3, 2014, both boards of directors from LJEC and Kaw Valley approved forming an alliance working toward a consolidation vote in April 2016.

Over the past six months we have worked toward bringing our processes, operations,

and employees together to capture savings with a target over \$13.5 million projected for the next 10 years. Watch for your monthly issue of *Kansas Country Living* magazine for updates to the cooperative's savings and accomplishments between both LJEC and Kaw Valley over the next 12 months.

Pre-Paid Programs & SmartHub

Our pre-paid program that was functioning as a pilot in 2012 has expanded and now has over 150 participants. Pre-paid is a great program for members that may fare better paying their bill in small increments versus one, big monthly bill. With this program, members avoid disconnect and reconnect fees—something that can put a member further behind each month. Pre-paid also encourages members to monitor usage through our online bill-pay system, SmartHub.

We continue to enhance existing programs available to our

2015 Annual Meeting

The 71st Annual Meeting of LJEC was held Tuesday, April 28 at the McLouth Elementary School Purple Gym.

This year's meeting focused specifically on the cooperative's alliance with Kaw

Valley Electric. The alliance was approved during a special joint meeting of the cooperatives' Board of Trustees on October 3, 2014, and is the first step toward a possible consolidation of the cooperatives on January 1, 2017.

Board president Larry Meadows called the meeting to order and introduced the members of the Board of Trustees.

Bob Funk, retired accounting manager was recognized for his 25 years of service, and new hires Joseph Fridlington and Sarah Farlee were introduced.

Martha Shaw, board secretary, read the notice of the meeting and the 2014 minutes were approved.

In the election of trustees for District 1. incumbent BILL POHL remained on the board. In District 4, incumbent LARRY MEADOWS retained the board seat, and in District 6, incumbent

Martha Shaw and challenger Margaret Saunders tied. A coin toss determined Saunders the winner of the District 6 seat. However, Saunders resigned the position back to **MARTHA SHAW**, who will resume board duties.

Meadows thanked the nominating committee of Don Baker, District 1; Jeff Brandau, District 4; Chop Marquardt, District 4; Larry Tripp, District 6; and Tom Swearngin, District 6.

In the leadership report, General Manager Steve Foss reported that the cooperative had a net margin of \$1.515.880 in 2014.

Foss also commented on the ways LJEC is working to control costs by installing Automatic Metering

> Infrastructure (AMI), refinancing cooperative debt, and installing peak shaving generators at two substations. In 2014, the generator savings equaled \$379,841 netting a 60 percent return on costs to install in 2012.

Foss pointed out that the continued focus is on costs that are controllable.

\$0.25 of every dollar pays the expenses of running the cooperative

- ▶ \$0.11 of every dollar goes to uncontrollable expenses (taxes, interest, depreciation)
- ▶ \$0.64 of every dollar pays for power purchased from the power supplier

This work to stabilize rates has also directed the cooperative to look at external opportunities. One of these opportunities is the alliance and possible consolidation with Kaw Valley Electric headquartered in Topeka. The alliance is an opportunity to help hold down rates and improve operating efficiencies by:

- ► Combining purchasing, billing and accounting, and member service functions
- ▶ Sharing equipment, software and engineering services
- Incorporating best practices and processes from both cooperatives
- ▶ Providing members with all of the value-added services and discounts available through each cooperative

Highlights

The alliance is an excellent fit for both cooperatives because of how we provide services. Our operations processes are similar and we use much of the same technology and equipment, which will allow us to efficiently and effectively blend functions to maximize cost savings.

Foss also introduced the new cooperative alliance management team:

- ▶ Manager and CEO (joint positions): STEVE FOSS (LJEC) and JERRY MANNING (KVE)
- Assistant Managers (joint positions): CHRIS PARR (LJEC) and KEVIN GREGG (KVE)
- ► Compliance and Resource Manager: **RANDY RICHARDS (KVE)**
- ▶ Finance and Accounting Manager: MICHELLE MEYER (KVE)
- ► Administrative Services Manager: **JENNIFER PING** (LJEC)
- ► Engineering Manager: ERIC WYLIE (LJEC)
- ► Operations Manager: **CURTIS HAVENSTEIN** (KVE)

Chris Parr, assistant manager, gave a Kansas Legislative Update regarding Kansas Senate Bill 261 that proposes to fund schools, state government and services by adding a tax passed on consumption. This would apply a 6.15 percent sales tax to residential electric bills where currently no taxes exist on electric usage. This sales tax is not a rate increase from LJEC, but a collection for Kansas. Parr encouraged members to contact tehir local legislator to take action against this bill.

Shannon Crouse spoke about LJEC programs that members can utilize, such as home energy audits, attic report cards, and Exede Internet satellite broadband services. He also announced that the LJEC Health Fair and Member Appreciation Day will be September 22, 2015, in McLouth.

Youth Trip winners TAMARA DRINKARD, winner of the 2014 Cooperative Youth Leadership Camp in Steamboat Springs, CO, and **LEAH PARSONS**, winner of the 2014 Electric Cooperative Youth Tour to Washington, D.C., gave reports and presentations about their trips. This year's trip winners were also recognized including MAD-**ELYN BROXTERMAN**, Jeff West High School, and **CARISSA** MCAFFEE, Jefferson County North High School who will attend Cooperative Youth Leadership Camp, as well as EMMA DEMARANVILLE, Tonganoxie High School, who will travel to Washington, D.C.

LJEC members are encouraged to contact the cooperative if they have any questions regarding the programs, services, or opportunities offered. LJEC is owned by the members and, therefore, here to serve the members.
