- C. Is currently an employee of the Cooperative or has been employed by the Cooperative within three years of the date of the election for the trustee position.
- D. Is a close relative (spouse, child, grandchild, grandparent, parent, sibling, niece, nephew by blood or adoption) of a person serving as a trustee or employee of the Cooperative.
- E. Has entered a plea of guilty or no contest or has been adjudged as guilty of a felony crime in the State of Kansas or any other state.
